Protecting your private information is our priority. This Statement of Privacy applies to the MoonlightELD.com and UZB2USA INC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to MOONLIGHTELD include MoonlightELD.com and MOONLIGHTELD. The MOONLIGHTELD website is an ELD provider site. By using the MOONLIGHTELD website, you consent to the data practices described in this statement.

Collection of your Personal Information

MOONLIGHTELD may collect personally identifiable information, such as your name, business name, email address and phone number. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by MOONLIGHTELD. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the MOONLIGHTELD website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through MOONLIGHTELD's information may be collected and used by others.

Use of your Personal Information

MOONLIGHTELD collects and uses your personal information to operate its website(s) and deliver the services you have requested.

MOONLIGHTELD may also use your personally identifiable information to inform you of other products or services available from MOONLIGHTELD and its affiliates. MOONLIGHTELD may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

MOONLIGHTELD does not sell, rent or lease its customer lists to third parties.

MOONLIGHTELD may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. MOONLIGHTELD may share data with trusted

partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to MOONLIGHTELD, and they are required to maintain the confidentiality of your information.

MOONLIGHTELD may keep track of the websites and pages our users visit within MOONLIGHTELD, in order to determine what MOONLIGHTELD services are the most popular. Use of Cookies

The MOONLIGHTELD website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize MOONLIGHTELD pages, or register with MOONLIGHTELD site or services, a cookie helps MOONLIGHTELD to recall your specific information on subsequent visits.
